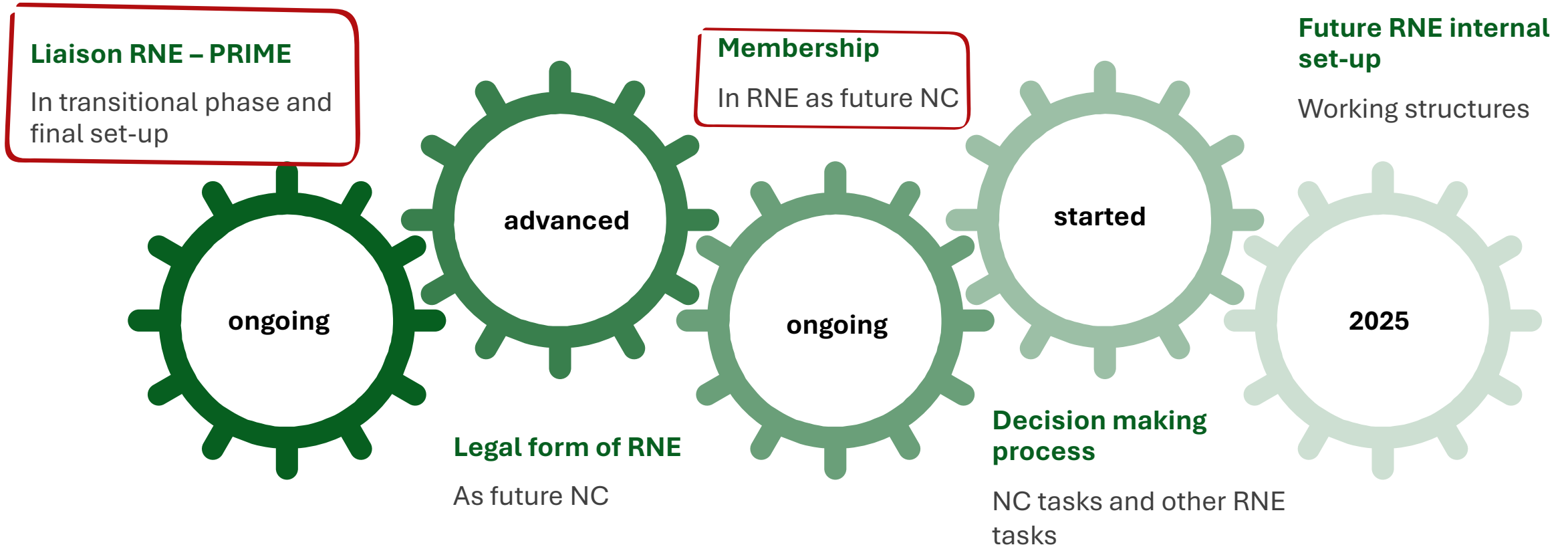
Analysis of possible future tasks of RNE/Network coordinator

Subproject 2 - Topics to be discussed with PRIME

1 Preparation of European Frameworks

Aspects

- procedural aspects (timelines, stakeholder involvement, etc.)
- Potentially selected topics

Timing: start in 2024

Possible ways of interaction:

- *Involvement of PRIME representatives in RNE task forces*
- *Regular reporting of RNE to PRIME representatives (level and frequency tbd)*
- *Reporting at PRIME Plenaries only*

2 Expectations on tasks of NC

Aspects

- Envisaged distribution of tasks between ENIM and NC
- Expectations re ENIM Secretariat (timeline, scope of tasks, interaction with PRIME, etc.)
- Expectations on Stakeholder involvement/consultation activities in transitional and final phase

Timing: 2025

Possible ways of interaction:

- *Discussion with PRIME Co-Chairs?*
- *Discussion at PRIME Plenary?*

3 Organisational set-up & NC appointment process

Aspects

- Conditions for appointment
- Procedure/act for appointment
- Procedure for monitoring work
- Submission of annual work programme and report
- Financing of NC activities

Timing: start in 2024 for topics relevant for trilogues (e.g. financing)

Possible ways of interaction:

- *meeting with PRIME Transition task forces?*
- *Meeting with PRIME Co-Chairs?*

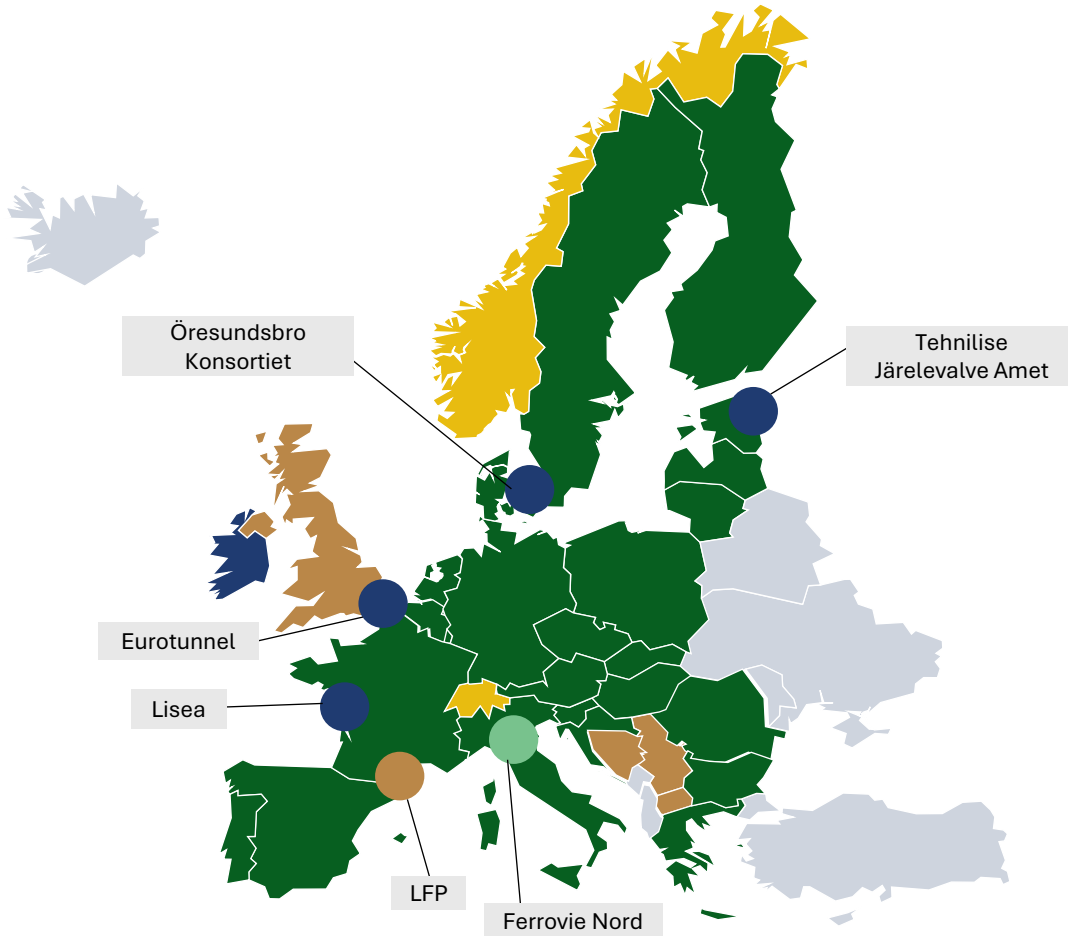
- RNE & PRIME Members today, ENIM Members under draft Regulation

Preliminary findings

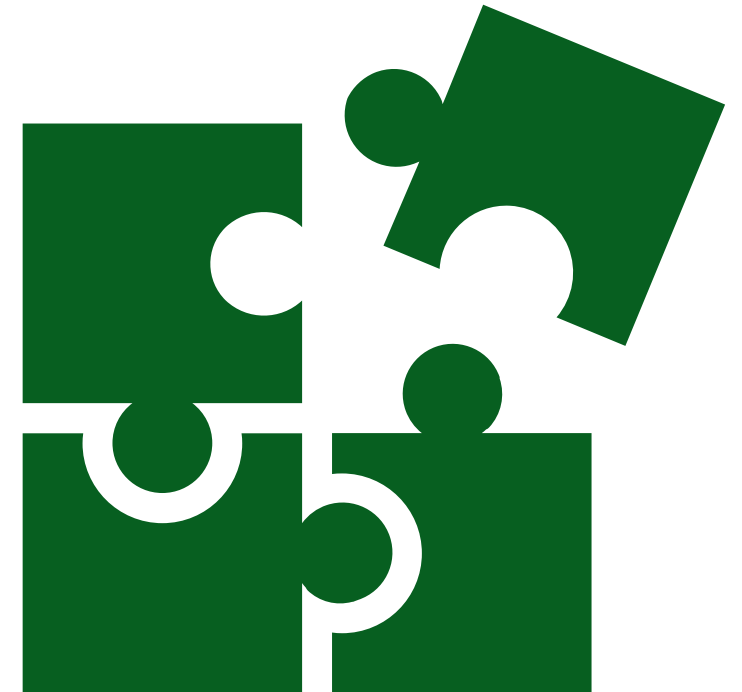
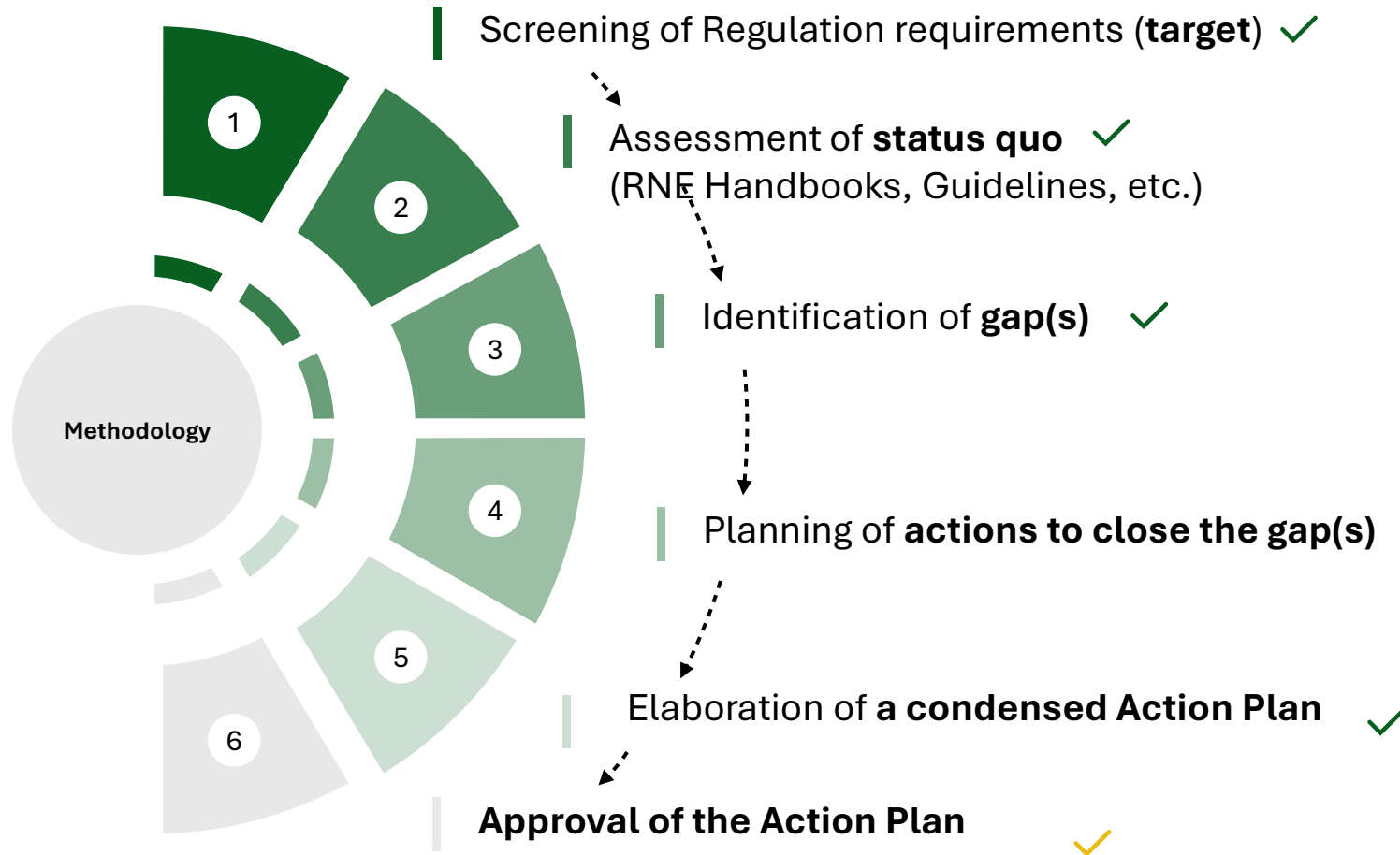
- ENIM & RNE Membership do not need to overlap also in future, when RNE exercises role of NC
